Chairman's Opening Address:

The Chairman duly welcomed all members to the meeting, held following the Annual General Meeting to discuss the co-option of a new Committee Member and review a couple of items of business.

Committee Vacancy - Co-Option

Mr. John Fenner had expressed an interest to serve on the League Management Committee. It was Proposed by Mr. Brian Stuchbury and Seconded by Mr. John Hedge that Mr. Fenner be co-opted onto the Committee, agreed unanimously.

MK Wanderers Res. F.C.

Following on from the Annual General Meeting, MK Wanderers had expressed their interest in re-entering a reserve team into the League for the coming season. There were mixed views on this and given that they withdrew following the Annual General Meeting 2015-2016 Season, Clubs would need to vote to re-elect MK Wanderers Res. into the League. The Secretary would write to MK Wanderers F.C. to enquire as to the nature of the team and players to ensure that the issues we had with their 'A' side was not repeated.

League Accounts

Mr. Aldren raised a query regarding the detail of accounts published to Member Clubs. The Chairman reported that the accounts that the League produce are in line with that produced by other Leagues and could show some examples of this. This item to be discussed at a future Committee Meeting when consideration of what other Members thought and what level of detail was being requested could be reviewed.

Twyford United F.C.

The Chairman advised that he had received correspondence from Twyford United F.C. regarding a player registration irregularity for MK Gallactico. The Chairman advised that he had replied in depth to this request and had received further communication confirming that the matter was closed.
