Fines for Breach of League Rules

Notification of fines raised since the last meeting on 2nd March 2017 will be issued separately directly with Clubs as noted on the Agenda. Charges for Breach of League Rules

Registration's Secretary's Report

The Registration Secretary advised that he had completed a number of match day registrations from the last weekend of the season on return from his holiday. The final total of players for the season was 1,802.

The Registration Secretary also advised that members of the Management Committee had attended a number of fixtures to complete Match Day Player Verifications. The following Clubs have completed match day registration checks since the last meeting and the Registration Secretary had checked and confirmed there were no irregularities:

- Willen Res. Vs Tattenhoe Res. (11th March 2017)
- Potterspurty Vs Great Linford (18th March 2017)
- Brackley Sports Res. Vs Hanslope Hanslope Res. (25th March 2017)

The Registration Secretary noted that a player previously registered with New City Stars F.C. had now registered with Clean Slate F.C. The Secretary would invoice for the player's apportionment with the next batch of invoices.

The Registration Secretary reported that there had been issues with the results e-mail address - in particular with the receipt of match reports from MK Wanderers. The Secretary would look into this with the e-mail hosting provider.

A reminder that Clubs who are still in semi-finals and / or finals of League Cup Competitions are to pay specific attention to the Rules of those competitions with regards to player eligibility and submission of proposed squad lists for those matches.

City Colts F.C. The Registration Secretary noted that City Colts FC had still not submitted their match report sheet from the 19th November 2016. The Secretary would contact the Club and advise they had 7 days to submit the outstanding form otherwise they would be suspended until it had been received.

MK Gallactico F.C. Following correspondence with the Club in connection with the Charges from the last meeting, it was the decision of the Management Committee as follows:

28th January 2017 Vs Duston Dynamo F.C. - The Club would be charged with playing unregistered or otherwise ineligible players and removed from the Interdivisional Cup Competition. Duston Dynamo F.C. to be reinstated.

4th February 2017 Vs Wing Village F.C. - The Club would be charged with playing unregistered or otherwise ineligible players and removed from the Intermediate Division Cup Competition. Wing Village F.C. to be reinstated.

Registration's Secretary's Report (Cont/d...)

MK Gallactico F.C. A discussion to place regarding MK Gallactico F.C.'s continued membership of the League, following on from the issues from last season, and the issues from this season. The Club were placed back on probation following last seasons' issues, and so far this season similar issues were still being encountered.

Referee's Secretary's Report

The Referee's Secretary advised that he had appointed Officials to the next set of fixtures due for release shortly, together with the Cup Final Appointments.

The Referee's Secretary advised that there were currently a number of referee's out with injuries and was currently struggling with evening appointments as a result of this.

Transfers

Fixture's Secretary's Report:

The Fixture's Secretary advised that the next set of fixtures had been completed and sent to the League Secretary for issue to Clubs. The Fixtures Secretary had been working to arrange provisional dates for League Cup finals.

The Fixture's Secretary noted that she was working with the South Midlands League, Marsworth Cup and Oving Village Cup fixtures secretaries to ensure full programmes were fulfilled each week, albeit the South Midlands League were now arranging fixtures on dates previously agreed would be North Bucks League dates.

Treasurer's Report

Social Media:

Clubs are reminded that any posts on Social Media (e.g. Twitter, Facebook, Websites) should not relate to other teams, officials etc.... The Football Association takes such posts very seriously and can result in charges being raised against Individuals and / or Clubs. All Clubs have a responsibility to ensure that any such media items are monitored.

Should any Club have any concerns over what is being posted on social media, they can contact the League or go directly to their respective County F.A.

Respect

The League reminds all Clubs and Officials of the FA Respect Programme, and that the North Bucks & District Football League is a designated Respect League. All parties are to ensure that the Respect Programme is followed at all times, in particular the pre-match handshake. A reminder to be sent to all Match Officials to ensure this is carried out.

Trophy Repairs

The Treasurer advised that a number of trophies had been taken to County Engravers for repairs as follows:

- Division One Cup: Being cleaned due to the condition returned in by Padbury Village F.C. Cost to be forwarded to the Club once known.
- Division Two Cup: Replacement Base required. Options for a Silver Base (£1,300.00), Wood Base (£149 plus bands, either Aluminium 3 x £45.00 or Silver 1 x £80.00). It was agreed that a wood base plus silver band would be purchased.
- Reserve Team Cup: Plate being added to base for future engraving.
